
The following Resolution was duly passed by the Board of Supervisors of the County of Placer at a regular meeting held February 23, 2016, by the following vote on roll call:



WHEREAS, Offers of Dedication were made to the public and accepted by Placer County for a Conservation Easement, Cultural Resource Easement, Natural Open Space Easement, Public Access Easement and Wetland Preservation Easement, and an Offer of Dedication was made for a Multi-Purpose Trail Easement, but not accepted by Placer County, on the Bickford Ranch Large Lot Subdivision Phase 1 Map, filed for record in Book BB of Maps at Page 77; and

WHEREAS, it has been determined that the accepted and not accepted Offers of Dedication for these easements, and as described on the attached Exhibit "A" and as shown on the attached Exhibit "B", are no longer necessary for present or prospective public use, as they will be rededicated on subsequent Bickford Ranch maps; and

WHEREAS, summary vacation of the easements and Offer of Dedication is permissible pursuant to Chapter 4 of Part 3, Division 9 of the Streets and Highways Code, commencing with Section 8330.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Placer County that from and after the date this Resolution is recorded, the easements and Offer of Dedication, as described and shown on the attached Exhibits, shall be vacated and abandoned, and shall thereafter not constitute easements or Offer of Dedication for their intended purposes; and

BE IT FURTHER RESOLVED by the Board of Supervisors of Placer County that the above described easements and Offer of Dedication, as described and shown on the attached exhibits, are not useful as a nonmotorized transportation facility.



EXHIBIT "A"

EASEMENT ABANDONMENT

All that real property situated in the County of Placer, State of California and located within Section 19, Township 12 North, Range 7 East, Mount Diablo Meridian, being all of the following easements dedicated to Placer County on that portion of Lot L-58B as shown and so designated on that certain Final Map entitled "Tract No. 918 Bickford Ranch-Large Lot Subdivision Phase 1", filed for record on July 6, 2007, in Book BB of Maps, at Page 77, Placer County Records lying within the Resultant Anders Property as described in that certain Grant Deed recorded on December 4, 2015 in Document Number 2015-0104687, Official Records of Placer County said easements being further described as follows:

1. C. E. – Conservation Easement
2. C. R. E. – Cultural Resource Easement
3. M. P. T. E. – Multi-Purpose Trail Easement
4. N. O. S. E. (N.O.S.) – Natural Open Space Easement
5. P. A. E. – Public Access Easement
6. W. P. E. – Wetland Preservation Easement


