ACTION REQUESTED

Approve appropriation of \$500 in Revenue Sharing monies to Acres of Hope for funding to support women and children service programs as requested by Supervisor Weygandt (\$250) and Supervisor Holmes (\$250).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants therefore a benefit results to the County.

Acres of Hope located in North Auburn provides housing and training programs for qualified single women with children who have been referred by local agencies and meet the qualifications of the home to live and learn the skills needed to reach specific life goals. The program uses case managers to keep the women accountable to the goals set for healthy living such as, parenting, mental health, relational skills and employment. This year they have three families that will be graduating from the program. An event is planned to help celebrate their 10th year of service to the Placer County community. The funds received from this request will help to cover the costs to organize this event so that funds can be raised for the future needs of the provided home services.
