
The Board of Supervisors is being asked to approve appropriations to help support the Lighthouse Counseling and Family Resource Center. The mission of the center is to strengthen families and improve the physical and emotional well-being of the residents of Placer County by providing counseling, educational classes, parenting support services, and access to resources at no cost to the community at large. Each year the center helps over 3,000 residents of the community with the majority of their clients being at poverty level or below. The funding received in the past is helping to launch their new in-home visitation program. Lighthouse Counseling will use 100% of the revenue share funds to support their various programs.

**Briefly describe the community benefit organization, event, program, or project provides:**


On Friday May 20<sup>th</sup>, 2016 Lighthouse Counseling & Family Resource Center is hosting its 10th Annual Celebrity Waiter Luncheon. The event will be held at Orchard Creek Lodge located in Sun City Lincoln Hills, CA. The event begins with a private reception at 11:00am followed by a luncheon from 11:30am-1:00pm. All proceeds will help Lighthouse administer its Family Wellness programs to help families in Placer County.

**Briefly describe how funding will be utilized by listing what items will be purchased:**

Over the past 10 years Lighthouse has been providing counseling, case management, and educational classes to more than 3,000 individuals and families that need extra help during challenging times. Our counselors are trained in child abuse and neglect prevention, attachment issues, postpartum depression, anxiety/depression, domestic violence, victims of crime, trauma and other family related matters. Our Family Resource Center provides client case management so that they receive the resources necessary to meet their ongoing needs such as MediCal, CalFresh, infant car seats, diapers, rent and utility assistance, and WIC benefits. Finally, we provide a wide array of classes such as positive parenting, dealing with depression and anxiety, anger management, budgeting, women's empowerment, family wellness and employment readiness. Because of generous sponsors like you, we will soon be launching our new in-home visitation program which will encompass the following: reducing childhood abuse and neglect, improving childhood literacy, oral health education, early childhood disability screening and childhood immunization education. All of our services are offered at no cost to the client and are provided in both English and Spanish. If awarded, 100% of the Revenue Sharing grant will be used to support the programs listed above.
