BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriation to the Placer Society for the Prevention of Cruelty to Animals (SPCA) to help fund their annual Funny Bones Comedy & Awards Night. The SPCA founded in 1973, provides many innovative programs such as kennel enrichment and socialization strategies, behavior modification counseling and training, foster care and mobile adoption that enhance animal well-being and improve adoptability. The SPCA also works closely with the community to provide adoption counseling, spay/neuter assistance and education, lost and found pets, pet classes and workshops, humane education, collaborative rescue efforts and volunteer opportunities. The funds designated towards this organization will help defray the cost of the event and fund programs and assist with their mission to enhance the lives of companion animals and support the human-animal bond.
