**ACTION REQUESTED**

Approve appropriation of \$250 in Revenue Sharing monies to The Forgotten Soldier Program’s *Annual 111 Mile Motorcycle Ride* for funding to support programs for veterans as requested by Supervisor Holmes.

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support The Forgotten Soldier veteran programs. The Forgotten Soldier Program was founded to help veterans who are having problems settling back into civilian life. The program provides assistance in the healing process of emotional and spiritual trauma and physical symptoms of veterans through the use of Holistic Therapy, at no cost to them. In the past 10 years, the Forgotten Soldier Program has helped over 17,000 veterans and their family members. These sessions are provided to veterans who are referred by the Veterans Association and the Wounded Warrior program. The annual *111 Mile Motorcycle Ride* is a fundraiser for the program. Over 300 riders participate along with members of the community. The ride ends with a barbeque and food at the Veteran Garden. The funds received will help to pay for the cost of this community event.
