


The following Resolution was duly passed by the Board of Supervisors of the County of Placer at a regular meeting held June 21, 2016, by the following vote on roll call:

WHEREAS, a Drainage Easement was dedicated to Placer County on the map of Moana Beach Subdivision, filed for record in Book H of Maps at Page 7; and

WHEREAS, it has been determined that the Drainage Easement on Lot 14 and a portion of Lot 13, as described on the attached Exhibit "A" and as shown on the attached Exhibit "B", is no longer necessary for present or prospective public use; and

WHEREAS, summary vacation of the easement is permissible pursuant to Chapter 4 of Part 3, Division 9 of the Streets and Highways Code, commencing with Section 8330.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Placer County that from and after the date this Resolution is recorded, the Drainage Easement on Lot 14 and a portion of Lot 13, Moana Beach, as described and shown on the attached exhibits, shall be vacated and abandoned, and shall thereafter not constitute an easement for its intended purpose; and

BE IT FURTHER RESOLVED by the Board of Supervisors of Placer County that the above described easement, as described and shown on the attached exhibits, is not useful as a nonmotorized transportation facility.

EXHIBIT "A"
LEGAL DESCRIPTION
DRAINAGE EASEMENT ABANDONMENT


A portion of the parcel of land situated in Section 7, Township 14 North, Range 17 East, M.D.M., Placer County, California, being a portion of Parcel One and a portion of Parcel Two as described in the Deed to Wendy J Warren, trustee of the revocable trust, recorded in Document No. 2015-0075611 O.R.P.C., also being a portion of Lot 14 and a portion of Lot 13 as shown on the map of Moana Beach Subdivision recorded in Book H of Maps at page 7, Official Records of Placer County, California, more particularly described as a 10 foot wide strip of land, 5 feet on each side of the following described centerline:

BEGINNING at the most Westerly corner of said Lot 14 also being the most Southerly corner of said Lot 13, and being a point on the right of way of Moana Circle as shown on Book H of Maps at page 7

Thence leaving said right of way, along the line common to said Lot 13 and Lot 14, North 44°03'00" East a distance of 269.42 feet to the Northeasterly boundary of said Lot 13 and Lot 14, shown as the low water line of Lake Tahoe on said Book H of Maps at page 7 and the **END POINT** of the centerline of this strip of land.

The sidelines of said strip shall be shortened or lengthened to end on the boundaries of said Lot 13 and Lot 14 of said Book H of Maps at page 7, shown as the low water line of Lake Tahoe on said map.

The Meridian of this legal description is identical to the bearings shown on the map of Moana Beach and Deed Document No. 2015-0075611.


