**ACTION REQUESTED**

Approve reappointment of Linda Scudder to Seat #3 (represents Co Child Care Providers), Michelle Stalder to Seat #9 (represents Co Discretionary Mbr), and Robert Green to Seat #10 (represents Co Discretionary Mbr).

**BACKGROUND**

The Child Care Local Coordination Task Force was discharged and the Child Care Advisory Council was set in place to implement the recommendations contained in the Child Care Master Plan, with the Committee being active until task is complete. The Child Care Advisory Council has members in each of the following categories: Consumers, Child Care Providers, Public Agency, Community Representatives and Discretionary Members. Seats #1 through #10 are County appointments with the Board of Supervisors appointing half of the members in each category and the County Superintendent of Schools appointing the other half of the members, Seats #11 through #20. Up to four members shall be child care providers, reflective of the range of child care in the county. Up to four members shall be public agency representatives. Up to 4 members shall be community representatives, who are not child care agencies. Up to 4 members shall be public members, at the discretion of the appointing agencies.

Terms of each member shall be three (3) years, with all terms ending on the 30th day of June of the corresponding year of their term. The Board of Supervisors shall appoint members from solicited applications by the County. Meetings are held the first Tuesday of January, March, May, September and November. The presiding officer, as needed, may schedule additional meetings, including public meetings.

Representation: Board of Supervisors shall appoint 1/2 of the members in each category and the County Superintendent of Schools shall appoint the other 1/2 of the members. Up to 4 members shall be consumers of child care, up to 4 members shall be child care providers, up to 4 members shall be community representatives, up to 4 members shall be public agency representatives and up to 4 members shall be public members, at the discretion of the appointing agencies. Terms of each member shall be three (3) years and will end on the 30<sup>th</sup> day of June of the corresponding year of their term. The Board of Supervisors shall appoint members from solicited applications by the County.

**MEETINGS:** First Tuesday of the following months: January, March, May, September and November. The presiding officer, as needed, may schedule additional meetings, including public meetings.

**COMPENSATION:** Members shall receive no compensation for their services; however, any member traveling on official business for the Council shall be reimbursed for his actual and necessary traveling expenses.
