ACTION REQUESTED

Approve appropriation of \$1,000 in Revenue Sharing monies to the Placer County Sheriff’s Activities League (PALS) as requested by Supervisor Weygandt (\$250), Supervisor Holmes (\$500) and Supervisor Uhler (\$250).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to help support the Placer County Sheriff’s Activities League (PALS). PALS was designed to reach out to at-risk and underprivileged youth. The volunteers offer the youth constructive activities that will deter them from engaging in criminal or risky behavior. These youth are encouraged to develop leadership and social skills, provide mentorship and promote teamwork through community volunteering, sports, and field trips.
