BE IT HEREBY RESOLVED, by the Placer County Board of Supervisors that Resolution 98-86 be replaced as follows:

<u>COUNCIL ESTABLISHED</u>: Pursuant to the provisions of the Government Code Section 31010, there is hereby established the Rural Lincoln Municipal Advisory Council.

TERRITORIAL JURISDICTION: The Council shall represent the territorial area as shown on attached Exhibit "A" (MAC boundary map) and shall jointly represent the area designated as the "Joint MAC Area"

COMPOSITION: The Council shall have (5) five at-large members, appointed by the Board of Supervisors.

QUALIFICATION FOR MEMBERSHIP: At-large members shall, at time of appointment and all times in term of office be at least one of the following: residents within the MAC boundaries, or property owners of real property within the area, or business owners or managers operating a business within such area, or a member of the United Auburn Indian Community (UAIC) or a current United Auburn Indian Tribal Council member. Failure to maintain such status shall result in a vacancy in office.

NOMINATION AND TERMS OF OFFICE: Members shall serve (2) year terms. Current term for Seat #1, #2 and #3 will end 12-31-2012. Current term for Seats #4 and #5 will end 12-31-2011. Subsequent terms for each seat are for a period of (2) two years.

<u>REMOVAL FROM OFFICE</u>: At any time, Members may be removed by a majority vote of the Board of Supervisors

<u>DUTIES OF COUNCIL</u>: The Municipal Advisory Council may advise the Board of Supervisors on matters of concern which relate to the *primary and joint MAC area* served by the Municipal Advisory Council. The Council

shall advise the Board of Supervisors on matters specifically referred to it by the Board of Supervisors for review and recommendation as described in County Ordinance No. 4661-B.

<u>PROCEDURAL RULES</u>: The Council shall adopt rules, regulations and procedures as are reasonable and appropriate for its activity, as are specifically approved by the Board of Supervisors. The Council shall also comply with any rules, regulations, and procedures contained in the MAC Manual proscribed and approved by the Board of Supervisors. In absence of procedures to the contrary, the council shall be governed by <u>Robert's Rules of Order</u>.

<u>RECORDS</u>: The Council shall keep all record of its actions in a form prescribed by the Placer County Auditor.

**COMPENSATION**: All members of the Council shall serve without compensation.
