### **A. Placer County Fire Mitigation Update**

Placer County is active in helping citizens mitigate the danger of fire in rural communities to which several actions are currently in progress – The Community Wildfire Protection Plan (CWPP), the Catastrophic Wildfire Strategic Plan Update and the activities of the Fire Safe Alliance and local Fire Safe Councils. ### **B. Farm Worker Housing Zoning Text Amendment**

Zoning text amendments are proposed to the Placer County Code (Zoning Ordinance) to bring the Code into compliance with State housing law for farm worker housing. The proposed changes will better define farm worker housing and allow such facilities to operate as an allowed agricultural use in the Residential-Agriculture (RA), Residential-Forest (RF), Agricultural Exclusive (AE), Farm (F), Forestry (FOR), and Timberland Protection Zone (TPZ) zoning districts with up to 36 beds in a group quarters or 12 units or spaces designed for use by a single family or household.

**C. Single Room Occupancy Zoning Text Amendment**

Zoning text amendments are proposed to the Placer County Code (Zoning Ordinance) to bring the Code into compliance with State housing law. SB2 amended housing law regarding planning and approval for Single Room Occupancy units. The County is proposing to amend the Zoning Code to define Single Room Occupancy (SRO) units (units lacking either cooking facilities or individual sanitary facilities, or both) and explicitly allow SROs as a residential use in the Multi-Family Residential (RM), Highway Service (HS), and Resort (RES) zoning districts.
