CONTRACTOR'S AGREEMENT:

I, the aforementioned duly licensed contractor performing the work under any On-line Permit(s) agree to the following terms and conditions when using On-line Permits.

Said duly licensed contractor shall not exceed the limits of the Scope of Work as indicated on the "**On-line Placer County Building Inspection Approval Record.**"

Said duly licensed contractor acknowledges that in the event the limits of the Scope of Work are exceeded resulting in additional required inspections, additional fees will incur at the rate as per the current Fee Schedule for each additional inspection for each discipline (electrical, mechanical, plumbing and building) and for plan review (if plans are required) plus administrative fees (records, etc.) as per the current Fee Schedule.

Said duly licensed contractor acknowledges that all documentation printed **with** the "On-line Placer County Building Inspection Approval Record" including, but not limited to energy forms and installation certifications shall be readily available to the field inspector upon request at all times or a re-inspection fee as per the current Fee Schedule will be due and payable at the Building Division office prior to any further inspections.

Said duly licensed contractor agrees that all job permits issued on-line will be within the limits of the scope of work indicated on the "On-line Placer County Building Inspection Approval Record" and all work performed under such On-line Permits will be in compliance with current applicable building codes.

Said duly licensed contractor understands and agrees that a job permit is required for each individual job, and the permit is valid for two years.

Said duly licensed contractor understands and agrees that an On-line Permit only becomes valid when the Building Division has received the required fees and the payment has been verified, receipt for payment issued (attach to field inspection card) and all of the Permit documentation has been printed and is readily available for the field inspector upon request.

Said duly licensed contractor will not perform any work in violation of property Covenants, Conditions and Restrictions (CC&Rs) and will obtain Homeowner's Association (HOA) approval if required.

Placer County reserves the right to restrict contractors from using On-line Permits if the contractor does not adhere to the Permit's "Limits of the Scope of Work."

LICENSED CONTRACTOR DECLARATION:

I hereby affirm under penalty of perjury that I am licensed under the provisions of Chapter 9 (commencing with Section 7000), Division 3 of the Business and Professions Code, and my license is in full force and effect.
