Letter 17C: Sherry Wicks, Chair, Foresthill Residents for respOnsible Growth, Inc.

Response 17C-A: The comment in opposition to the Forest Ranch Concept Plan Component of the FDCP is noted. This is a comment on the merits of the proposed Foresthill Divide Community Plan and does not raise a significant environmental issue that requires a response in this Final EIR.

Response 17C-B: Placer County staff has performed an analysis of capital improvement needs and costs over the 20-year horizon corresponding to the year 2030 DEIR analysis time frame and spreading those costs over the anticipated growth. The analysis indicated that the improvements needed for the year 2030 time frame could be fully funded, based on maintaining traffic operations at LOS D or better, in keeping with FDCP Policy 5.A.1-1. A preliminary analysis performed by the County indicates that the traffic mitigation fee required to fully fund the improvements range between \$2500 to \$5000 per Dwelling Unit Equivalent.
