

Notice: Proposed Garbage Fee Increase

For the past several years the Board of Supervisors has worked to minimize garbage collection fee increases, including keeping the disposal costs embedded in the fees stable since 2008, and worked with Tahoe Truckee Sierra Disposal to limit year-to-year increases in collection costs. In April, the Board of Supervisors will consider increasing garbage collection fees in County Franchise Area 3 to account for increases in operating costs. If approved, the new fees will take effect July 1, 2014. The proposed increases vary, depending on the level of service, but would not exceed 2.6%. California law (Proposition 218) provides customers who have mandatory service with the following options for participating in the fee approval process.

Proposed Fee Examples

- Monthly single can fees increasing from \$18.81 to \$19.29.
- Monthly three-yard commercial bin fees (weekly pick up) are proposed to increase from \$223.03 to \$226.50.

Submitting a Protest

The Board will consider written protests concerning the proposed increases in fees.

If a majority of affected property owners file written protests, the proposed changes will not be imposed. State law provides that only the written protests of property owners may be considered to determine if a majority protest exists. No more than one protest per property may be submitted.

Options for Protesting
