PLACER COUNTY PROBATION COMMUNITY EDUCATION SCHOLARSHIP

The Placer County Probation Department has a limited amount of scholarship funds available which may be able to pay minimal amounts for GED prep classes and/or materials and tests, California High School Proficiency Exams, Junior College admission fees, including textbooks, other approved vocational colleges, or other approved academic needs that promote education. The amount of scholarship funds awarded varies and is determined after your application has been considered by the scholarship committee. A determining factor in being awarded scholarship funds, is that the applicant must have exhausted all other resources of financial assistance i.e., financial aid through the school, grants, etc. The fees are paid by the Probation Department directly to the school or GED provider however, the funds do not cover housing or daily living expenses such as food and clothing.

Please fill out the application with as much information as you can provide the committee at this time so we can give your application complete consideration. If you are a Placer County Jail inmate, you should include your tentative release date and if you have a supervision officer, his or her name.
