 - A. **Sheridan Sewer - Proposed Fee Increase**—Placer County Staff will be requesting that the Placer County Board of Supervisor consider increases to the Sewer Service Charges in Sewer Maintenance District 1-Sheridan over the next five years starting on August 1, 2023. The proposed annual increases would be 7% for the first two years and Cost of Living Adjustments (COLAs) for the remaining three years based upon the Water/Sewer/Trash Consumer Price Index from the United States Department of Labor Bureau of Labor Statistics website with the annual increase not to exceed 5%.
