Subject: **DELINQUENT GARBAGE COLLECTION BILLS: FRANCHISE AREA 3  
(TAHOE)**

**ACTION REQUESTED / RECOMMENDATION:** Adopt the attached Resolution authorizing and directing the County Auditor to place for collection the delinquent garbage collection bills identified in Exhibit A of the attached Resolution for Franchise Area 3, plus a \$40.00 administrative fee per account, on the 2011/12 tax rolls unless otherwise paid in full by July 20, 2011.

**BACKGROUND:** Garbage collection service is mandatory in Franchise Area 3 (Donner Pass to Lake Tahoe). The County is contractually obligated to pay Tahoe Truckee Sierra Disposal (TTSD), the Franchisee for Area 3, for any customer billings that are more than 60 days delinquent as of March 31<sup>st</sup> of each year. The County recovers the balance of the unpaid accounts through annual property tax billing. In addition, your Board has historically approved the assessment of a \$40.00 administrative fee, per account, to cover the County's administrative costs associated with collecting the unpaid bills. TTSD has submitted a list of 253 unpaid accounts totaling \$54,235.69. Of this amount, 17 accounts totaling \$1,426.36 (see Exhibit B to the attached Resolution) have been identified as uncollectible through the tax rolls due to changes in property ownership. The remaining 236 accounts, totaling \$62,249.33, including the administrative fee, are listed in Exhibit A of the Resolution.

The owners of properties with delinquent accounts have been individually notified via mail of our intent to place their bills, plus a \$40.00 administrative fee, on the tax rolls (Attachment 1). The property owners have until July 20, 2011, to clear the delinquent accounts. Any cleared accounts will be removed prior to being sent to the Auditor's Office. In order to place the delinquent accounts and the associated administrative fees on the tax rolls, your Board must adopt the attached Resolution.

**ENVIRONMENTAL CLEARANCE:** The placement of delinquent garbage bills on the tax rolls is not considered a project under the California Environmental Quality Act.

**FISCAL IMPACT:** Placement of the delinquent accounts and associated administrative fees on the tax rolls will result in the County recovering \$52,809.33 for the unpaid bills and \$9,440 in administrative fees to offset the costs associated with calculating, collecting, and tracking unpaid bills. A total of \$1,426.36 in unpaid bills will remain uncollectible.
