TO ADOPT A MITIGATED NEGATIVE DECLARATION**

In accordance with the California Environmental Quality Act (CEQA) (Public Resources Code 21000 et seq.), the CEQA Guidelines (Title 14 Code of Regulations Section 15000 et seq.), and the County of Placer Procedures for Implementation of CEQA, an Initial Study and proposed Mitigated Negative Declaration has been prepared for this project that identifies and evaluates the environmental impacts of the project; and has been filed with the County Clerk's office.
