## **ACTION REQUESTED**

Approve a Resolution appointing the Placer County Office of Economic Development (OED) to be the official representative for Placer County in matters pertaining to the 2010 State Fair Exhibit and executing the California State Fair Official Entry form.

## **BACKGROUND**

For more than twenty years, Placer County has participated in the preparation of an exhibit at the California State Fair. In 2009, the Facility Services Department transitioned the responsibility for the Exhibit to the Office of Economic Development. This transition was considered very successful and the County received two gold ribbons and a Best Use of Technology award. The Office of Economic Development has agreed to be the lead Department again this year and will be working with the Director of the Placer County Visitor's Bureau/California Welcome Center to prepare and promote the exhibit for Placer County for 2010.

The exhibit has always highlighted Placer County's exceptional recreation and historical opportunities available to visitors and residents. In addition, tourism, education, the arts, and Placer County heritage have been showcased. Placer County's proximity to Cal Expo is of extreme benefit. Thousands of Placer County residents visit the fair and dozens also volunteer to represent the County in the Exhibit during the fair.

Participation in this event is encouraged by the California State Fair as a means to promote all of the counties in California and specifically provides an opportunity to demonstrate the variety of activities available in Placer County. The OED will again be the County's official representative for the 2010 State Fair which will open this year on Wednesday, July 14<sup>th</sup> running through Sunday, August 1<sup>st</sup>, 2010.
