**ACTION:**

Approval of the attached salary ordinance would implement a 2% salary range increase for the County Executive Officer.

**BACKGROUND:**

Following the recent evaluation of the County Executive Officer, the Personnel Department is bringing forward for your Board's consideration a proposed new salary range for the County Executive Officer position that would result in a 2% increase in the salary schedule. The specifics are as follows:

**FISCAL IMPACT:**

The estimated annual cost increase at step 3 of the new range would be \$5,298 including the corresponding increased cost of related benefits. It is expected that this amount would be absorbed in the currently approved budget for the County Executive Office.
