BACKGROUND

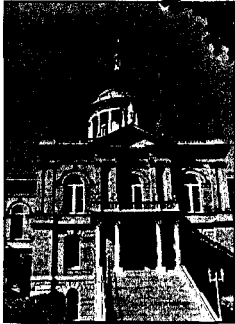

Returning from an inter-jurisdictional transfer to the State during which time she helped develop and implement a computerized automated tracking system for public health client demographics, and then became the Director of Public Health Nurses with oversight over many public health programs. She then facilitated a unique, innovative, and special legislated association with the State of California's Department of Health Services by combining sixteen separate public health programs into one consolidated contract; scope of work, and budget, thereby implementing a new system of seamless health care delivery, which other counties have sought to replicate. Vicki's many talents, loyalty, and integrity have played a critical part in the continued growth of Community Health with her technical and communication skills, along with her ability to deal with people at all levels has truly been an asset to our County.
