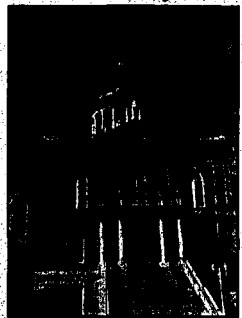

**Whereas, Charlie came to the Placer Mosquito Abatement District in 2000 after retiring from the Marin-Sonoma Mosquito and Vector Control District as the Manager/Biologist, and**

**Whereas, Charlie was instrumental in developing and implementing a Mosquito Abatement program in Placer County at a time when Placer County desperately needed this program to get control over a potentially increasing problem, and**

**Whereas, through the Mosquito Abatement program, Placer County has successfully limited the number of cases of West Nile Virus reported in Placer County, a deadly disease spread through mosquito bites that has been on a rapid upswing nationwide; and**

**Whereas, The objectives of the Mosquito Abatement program are to control or eliminate existing mosquito breeding sources and to prevent new ones to protect the public health and comfort.**
