SUBJECT: **GLADDING ROAD AND LOZANOS ROAD BRIDGE REPLACEMENT PROJECT -
CONTRACT NO. 73232**

ACTION REQUESTED / RECOMMENDATION

Approve a Resolution authorizing the Chairman to execute Contract Amendment No. 1 with Harris and Associates in the amount of \$142,275 to increase the total contract amount to \$369,710 for the construction management, inspection, and materials testing services for both the Gladding Road and Lozanos Road Bridge Replacement Project and authorize the Director of Public Works to approve and sign contract amendments for additional Professional Services not to exceed \$55,000.

BACKGROUND / SUMMARY

On December 13, 2005, the Board of Supervisors approved a professional services agreement with Harris and Associates to perform construction management, inspection, and materials testing services in the amount of \$227,435 for the Gladding Road Bridge Replacement Project. The County is requesting that a contract amendment be executed to utilize the same team from Harris & Associates on the Lozanos Road Bridge Replacement Project. Due to the size and location of these two projects, it is possible to utilize the same Construction Management team simultaneously on both projects. In doing this, the County will see a cost savings. Since Harris & Associates was selected out of a competitive process for the Gladding Road Bridge Replacement project and were determined to be the most qualified consultant, and the same team would be used for Lozanos, we feel that we would still have the most qualified team in addition to the economy of scale that we would receive.

The Procurement Division of Administrative Services support award of the contract to Harris and Associates.

ENVIRONMENTAL

The Professional Services Agreement is exempt from CEQA pursuant to CEQA Guidelines, Section 15306.

FISCAL IMPACT

The total construction cost for the Lozanos Road Bridge Replacement Project including construction management is estimated to be \$2,700,000. The project is funded through the Federal HBRR Program (88.53%) and County Traffic Mitigation Fees and Road Funds (11.47%), which will provide adequate funding for this contract with Harris and Associates. Funding for construction of the project is included in the 2005/2006 Fiscal Year Budget.
