ACTION REQUESTED / RECOMMENDATION

Adopt a resolution approving the project plans and specifications, authorizing the Chairman of the Board to sign the cover sheet, and authorize the Department to advertise for bids.

BACKGROUND/SUMMARY

The Department of Public Works is proposing to replace the existing bridge and realign the approach roadway on Lozanos Road at Auburn Ravine. The project is being completed under the Federal Highway Bridge Rehabilitation and Replacement (HBRR) Program. The project will replace the deteriorating bridge structure and reconstruct new roadway approaches.

DPW staff has met with local residents and the local Municipal Advisory Committee to review the proposed improvements. By implementing a sensitive design philosophy, County staff and residents were able to develop a mutually acceptable design. The proposed design preserves the rural atmosphere desired by the residents and limits tree removal, while providing new a bridge and approach roadway that is wider and structurally sound. Construction is planned for the summer of 2006.

ENVIRONMENTAL

Categorical Exclusion was obtained in accordance with the National Environmental Protection Act on August 28, 2003. A Mitigated Negative Declaration was approved on June 30, 2005. A Notice of Determination was filed on December 19, 2005.

FISCAL IMPACT

The total construction cost of the project is estimated to be \$2,800,000. The project is funded through the Federal HBRR Program (88.53%) and Road Fund (11.47%). Funding for construction of the project will be included in the 2005/06 and 2006/07 fiscal year budgets.

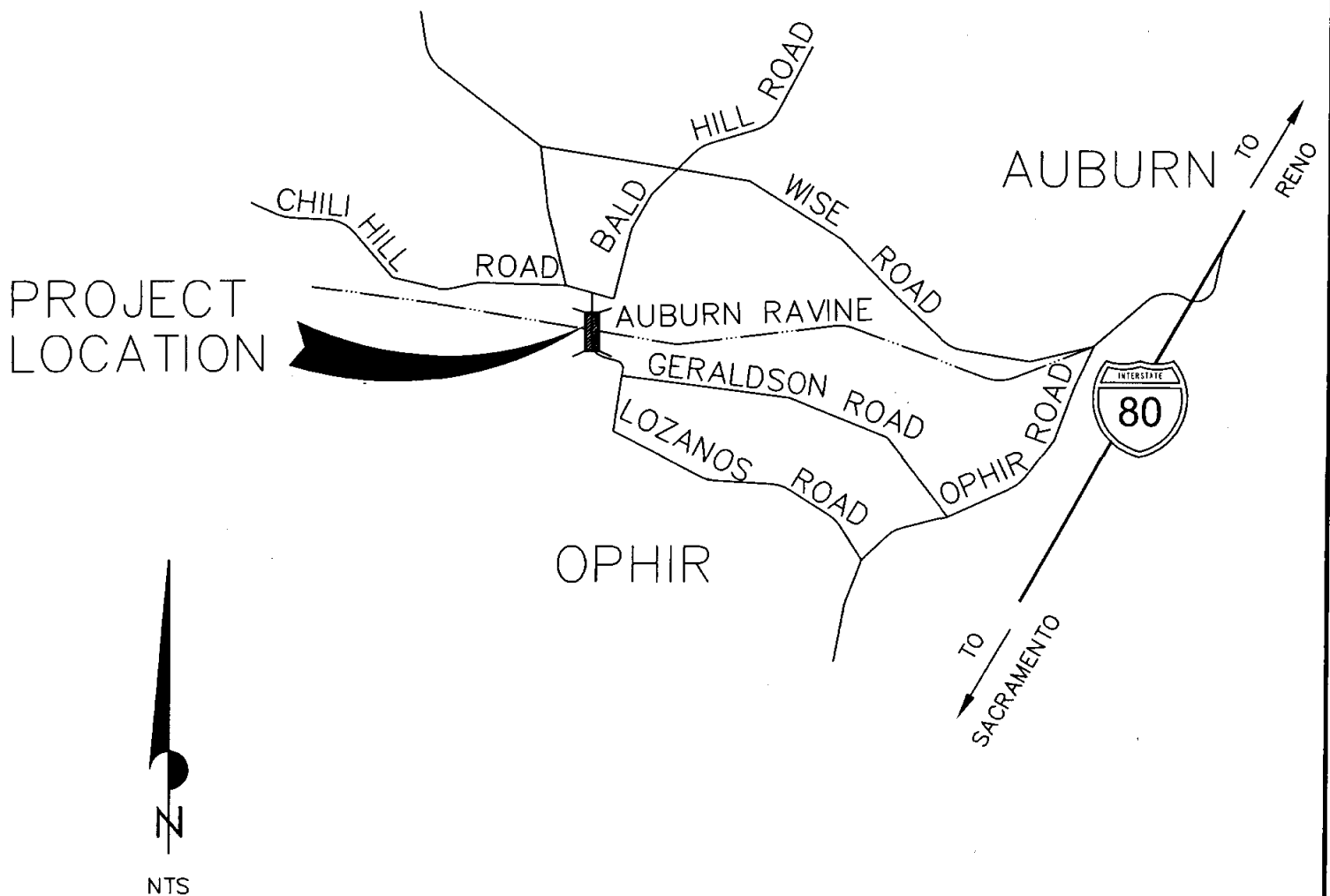
