SUBJECT: SQUAW VALLEY ROAD BRIDGE REHABILITATION PROJECT

ACTION REQUESTED / RECOMMENDATION

Approve a resolution authorizing the Chairman of the Board to sign and approve the project plans and specifications, authorizing the Department of Public Works to Advertise for Construction Bids, and authorizing the Director of Public Works to award and execute the construction contract for the Squaw Valley Road Bridge Rehabilitation Project up to an amount of \$1,200,000 and approve contract change orders up to \$200,000.

BACKGROUND / SUMMARY

The Department of Public Works is proposing to rehabilitate the existing bridge on Squaw Valley Road over Squaw Creek by replacing the existing bridge deck with a new pre-cast concrete bridge deck. The project is being completed under the Federal Highway Bridge Rehabilitation and Replacement (HBRR) Program. The project will replace the existing superstructure, which is deteriorating due to the freeze-thaw exposure and the de-icing sand utilized in the region and will also widen the superstructure to provide for water quality and snow removal improvements.

ENVIRONMENTAL

This project is exempt from California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15302 – Class2. A Notice of Exemption was filed with the Placer County Recorder on January 10, 2005. A Programmatic Categorical Exclusion was also received from Caltrans for the NEPA (National Environmental Protection Act) process on December 22, 2004.

FISCAL IMPACT

The construction cost of the proposed project is estimated at \$1,000,000. The construction contract will be funded through the Federal HBRR Program (88.53%) and County Road Funds/Traffic Fees (11.47%). There are sufficient funds available in the proposed FY 05/06 budget to accommodate this contract.
