BACKGROUND

Peter Hill is an outstanding community servant to his city, county, and the region. He has served on the Rocklin City Council for 29 years and has been Mayor six times. As a member of the City Council Mr. Hill has willingly taken on major county and regional responsibilities as well as those for the City of Rocklin.

In addition to these direct city responsibilities, Peter Hill's membership on the Council has led him to serve as a Board Member to the Placer County Air Pollution Control District. Peter Hill is always first on the board to stand behind the air quality standards established to protect even the most sensitive individuals in our communities.

Peter Hill has served a vital role on the Placer County Transportation Planning Agency and this agency has also shown remarkable success in the last few years. Most notable is the completion of the Highway 65 Lincoln Bypass, a roadway that was built despite greatly diminished highway funding in the State of California.

Currently Peter Hill is Chair of the Board of Directors for the South Placer Regional Transportation Authority that was formed with his support in January 2002 to establish a Regional Transportation Impact Fee Program. This fee program has been the foundation for the successful procurement of funds for local road improvement projects namely the Highway 65 Lincoln Bypass.

As a City Council member of Rocklin Peter Hill is requested to serve on local, county, and regional boards but Mr. Hill's service on these boards goes beyond the typical participation given.
