## ACTION REQUESTED / RECOMMENDATION

1. Adopt a Resolution for the Department of Public Works to revise the Proposition 1B Project List.
2. Approve the revised project list for the 2009-2010 allocation of Proposition 1B Local Streets and Roads funding totaling \$5,679,180 with no net County cost.

## BACKGROUND / SUMMARY

Proposition 1B, approved by California voters in November 2006, provided for \$19.925 Billion in bond funds for a variety of transportation priorities, including \$2 billion for California cities and counties to fund the maintenance and improvement of local transportation facilities. Approximately \$1 billion of this amount is for the counties, and Placer County has received and spent two previous Proposition 1B disbursements.

Special requirements for receiving this funding were developed by the legislature and include Board of Supervisor approval for projects to be funded with 1B funds, approval of list by the State Department of Finance, and strict requirements for timely expenditure of the funds.

In January 2010 your Board approved the original project list which proposed to utilize approximately \$4,291,212 of the 2009-2010 allocation for the local match on the \$70 million Foresthill Bridge Seismic Retrofit and Paint Project, and the remaining \$1,387,968 funds on an Asphalt Overlay Project. On July 26, 2011, after the low bid received and awarded for the Foresthill Bridge Seismic Retrofit and Paint Project came in much lower than expected with a projected "surplus" in the allocated Proposition 1B funds. Public Works revised the project list to include additional projects in order to make full use of the Proposition 1B funds prior to their expiration. However, now that we are approaching the expiration date of June 30, 2013 for these funds, Public Works has revised the list once again to ensure that all funds will be spent prior to the expiration date. No additional funding will be realized through this action; however it will prevent funding from being lost. Attachment A is the revised list of projects and provides detailed information. Board action is required to approve the revised project list for anticipated Proposition 1B funds in the amount of \$5,679,180.

## ENVIRONMENTAL

Approval of the project list is not a project as defined by the California Environmental Quality Act (CEQA). Each individual project will be subject to CEQA and the County's environmental review ordinance prior to project approval.

## FISCAL IMPACT

Placer County's share of Proposition 1B revenues for local streets and roads is at \$5,679,180 and has been received. The funding will be programmed in the Department's fiscal year budgets as appropriate.
