WHEREAS, Congress adopted the Disaster Mitigation Act 2000 (DMA-2000) on October 31, 2000. The emphasis of DMA-2000 is on creating an ongoing, community-wide public/private planning results in the local governing board formally adopting an Local Multi-Hazard Mitigation Plan (LHMP); and

WHEREAS, the Board of Supervisors adopted Implementation Program 8.14 to require the preparation and adoption of a LHMP; and

WHEREAS, the LHMP represents a comprehensive description of the County's commitment to reducing, preventing or eliminating potential impacts of disasters caused by natural hazards; and

WHEREAS, the Board adopted the LHMP in 2005 and adopted an update in 2010; and

WHEREAS, on May 17, 2016 the Placer County Board of Supervisors adopted the Placer County 2016 Local Multi-Hazard Mitigation Plan ("2016 LHMP"); and

WHEREAS, the Federal Emergency Management Agency approved the 2016 LHMP on June 13, 2016 and requires the County General Plan to incorporate by reference into the text of the Safety Element each update of the LHMP; and

WHEREAS, the Board finds this to be an administrative amendment to Implementation Program 8.14 of the General Plan Safety Element and which does not include changes in land use designations, or the land use map or the capital improvement program; and

WHEREAS, the Board finds the amendment is exempt under the California Environmental Quality Act; and

WHEREAS, the Board finds this administrative amendments to the General Plan will serve to protect and enhance the health, safety and general welfare of the residents of the County as a whole by providing a reference to the updated version of the County's LHMP for the use of all Placer County residents; and

WHEREAS, the Board finds the proposed General Plan administrative amendment is consistent with other provisions of the General Plan and its related Community and Area Plans, and is in compliance with applicable requirements of State law.

BE IT RESOLVED, by the Board of Supervisors, County of Placer, State of California, hereby amends Implementation Program 8.14 of the Placer County General Plan Safety Element to reference the 2016 LHMP, as indicated in Exhibit A and directs the updated printed version of the General Plan to identify the date of adoption of this resolution and include a copy of this resolution.

BE IT FURTHER RESOLVED, this Resolution shall take force and become effective immediately.

HEALTH AND SAFETY ELEMENT

Implementation Program 8.14

A Local Hazard Mitigation Plan shall be prepared and adopted in accordance with the Federal Disaster Mitigation Act of 2000 and Government Code 65302.6 shall serve as the implementation program for the coordination of hazard mitigation planning and disaster response within the County. The Local Hazard Mitigation Plan shall be reviewed annually by the County Office of Emergency Services and updated as necessary to ensure compliance with the Federal Disaster Mitigation Act of 2000, as it exists or as may be amended.
