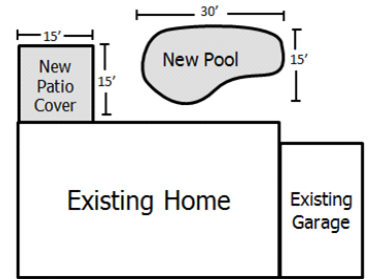
DIAGRAM OF NEW CONSTRUCTION
