

WHEREAS, Resolution 88-218 established a service fee on every owner of improved property in Solid Waste Franchise Area 4 (Foresthill), and further allows the County to assist in the collection of accounts that are more than one year delinquent through a lien on the subject property; and

WHEREAS, the Franchisee for Foresthill is Recology-Auburn Placer (Recology); and

WHEREAS, Recology has submitted Exhibit A, a list of 121 parcels with a total of \$28,658 in delinquencies, including penalties, attached hereto and incorporated herein by this reference, for inclusion of the County Tax Rolls; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors hereby authorizes and directs the County Auditor to place for collection the amounts shown on Exhibit A on the FY 2016-17 Tax Roll unless otherwise paid in full by June 30, 2016.
