ACTION REQUESTED/RECOMMENDATION

Approve the addition of a HP LaserJet Printer (Attachment A) to the Master Capital Asset Listing in the amount of \$5,540.86 (Attachment B) and authorize the Purchasing Manager to execute any related documents.

BACKGROUND

The Auditor's Office existing payroll printer is unreliable and requires continued repairs. In addition, the existing printer has expended its useful life. The Auditor's Office had budgeted to replace this printer in the 2012-13 fiscal year; however, we feel it is necessary to replace it now. Replacement cost is \$5,540.86.

Replacement of equipment that exceeds \$5,000 must be added to the Master Capital Asset List. Your Board's approval is required to authorize the addition of the printer to the Master Capital Asset List and to authorize the Purchasing Manager to execute any related purchasing documents.

FISCAL IMPACT

The Auditor's FY 2011-12 current budget has sufficient funding to cover the cost of the replacement printer.
