**SUBJECT:** Appoint Members in Lieu of Election to the Democratic Central Committee

**Recommendation**

Approve the attached resolution appointing in lieu of election the individuals who completed the Central Committee candidate filing process for the Democratic Central Committee.

**Background**

California Elections Code Section 7228 provides for the appointment of Democratic Central Committee Members in lieu of election if by 5:00 PM on the 73<sup>rd</sup> day prior to the election, the number of nominees does not exceed the number of offices to be filled at that election and no petition for a write-in campaign signed by 25 registered voters affiliated with the political party involved has been presented to the Office of Elections.

The Democratic Central Committee, Second (2<sup>nd</sup>), Third (3<sup>rd</sup>), Fourth (4<sup>th</sup>) and Fifth (5<sup>th</sup>) Supervisorial Districts were scheduled to have their central committee elections on June 5, 2012. Having an insufficient number of candidates to force an election in the districts and receiving no such petition in the districts by March 26, 2012, the elections have been cancelled and your Board must appoint the nominees to terms in these districts as specified in Exhibit A.

WHEREAS, Election Code Section 7228 provides for the appointment of members to the Democratic Central Committee if the number of candidates nominated does not exceed the number to be elected, and no petition for a write-in campaign is signed by 25 registered voters affiliated with the political party involved, within the time specified by law; and

WHEREAS, the number of nominees for positions on the Democratic Central Committee, Second (2<sup>nd</sup>), Third (3<sup>rd</sup>), Fourth (4<sup>th</sup>) and Fifth (5<sup>th</sup>) Supervisorial Districts did not exceed the number of vacancies, and no petitions for write-in campaigns were submitted to the Placer County Clerk-Recorder-Registrar of Voters; and

WHEREAS, the Placer County Office of Elections has verified these facts by conducting election services for the Democratic Central Committee; and

WHEREAS, the nominees for the Democratic Central Committee, Second (2<sup>nd</sup>), Third (3<sup>rd</sup>), Fourth (4<sup>th</sup>) and Fifth (5<sup>th</sup>) Supervisorial Districts are listed, and attached hereto, in Exhibit A;

NOW, THEREFORE, BE IT RESOLVED, that the Placer County Board of Supervisors approves the appointment in lieu of election of the nominees listed in Exhibit A to the Democratic Central Committee, Second (2<sup>nd</sup>), Third (3<sup>rd</sup>), Fourth (4<sup>th</sup>) and Fifth (5<sup>th</sup>) Supervisorial Districts; and

BE IT FURTHER RESOLVED, that the oath of office shall be administered to the newly appointed Democratic Central Committee members of the Second (2<sup>nd</sup>), Third (3<sup>rd</sup>), Fourth (4<sup>th</sup>) and Fifth (5<sup>th</sup>) Supervisorial Districts who shall, when qualified, take office and serve exactly as if elected at a Primary Election.
