ACTION REQUESTED

1. Approve the renewal of a competitively awarded blanket purchase order with Tri-Signal Integration, Inc. of El Dorado Hills for fire alarm system response, inspection, testing, and maintenance services in the maximum amount of \$53,700, funded by the Department of Facility Services' FY 2013-14 Building Maintenance budget with no additional net County cost, for the period of January 1, 2014 through December 31, 2014, and authorize the Purchasing Manager to sign the resulting blanket purchase order.

BACKGROUND

The Department of Facility Services requires an annual blanket purchase order (BPO) for routine service, maintenance, repair, and annual inspections and testing of six fire alarm systems located at various sites throughout Placer County. These six locations are required to have their fire alarm systems operational 24 hours a day, 365 days a year. On November 20, 2012, your Board approved the award of competitive Bid No. 10175 to Tri-Signal Integration of El Dorado Hills to provide these services. The resulting BPO expires December 31, 2013.

Tri-Signal Integration agreed to renew for a one-year term at the same pricing, terms, and conditions. The Bid's General Terms and Conditions allow for the renewal of the contract based upon the vendor's reasonable pricing and satisfactory performance.

Your Board's approval is required to proceed with a new one-year BPO in the maximum amount of \$53,700 and to authorize the Purchasing Manager to sign the resulting BPO.

FISCAL IMPACT

Upon your Board's approval, a new BPO will be awarded to Tri-Signal Integration in the maximum amount of \$53,700 effective for the period of January 1, 2014 through December 31, 2014. The department's Fiscal Impact Statement is attached.
