THE BOARD OF SUPERVISORS OF THE COUNTY OF PLACER, STATE OF CALIFORNIA,  
DOES HEREBY ORDAIN AS FOLLOWS:

That this ordinance modifies the provisions of the un-codified Schedule of Classifications and Compensation Ordinance for DSA Safety, DSA Non-Safety, Management Safety and the Board of Supervisors (Supervisor) classifications as set out below.

**Section 1. Measure F Increases**

Effective pay period 18, beginning February 2, 2019, pay date March 1, 2019, the following classifications and grades shall receive the increases identified below:

<u>Classification</u>	<u>Sal Plan - Grade</u>	<u>Percentage Increase</u>
Undersheriff	MGTS – S53	3.16%
Captain	MGTS – S51	6.36%
Lieutenant	MGTS – S50	6.40%
Sergeant	DSAS – 754	3.12%
Deputy Sheriff II	DSAS – 752	3.68%

**Section 2. Other Associated Law Enforcement Increases**

Effective pay period 18, beginning February 2, 2019, pay date March 1, 2019, the following classifications and grades shall receive the increases identified below:

Investigator – Welfare Fraud – Supervising	DSAN – NS4	3.12%
Chief Deputy Coroner	DSAS – 753	3.12%
Assistant Sheriff	MGTS – S52	3.16%

**Section 3. Placer County Charter Section 207 Increases**
