


Homeowners Insurance Challenges in Placer County Survey - 2019


1. Has your homeowners insurance been canceled or have you received a notice of non-renewal?




Did they do a site visit to your home before the cancellation?


Have you filed a claim with the California Department of Insurance?









Is the California FAIR Plan part of your new policy?





15. Is your neighborhood part of an established Firewise Community?




