- **Placer Commuter Express – Route #60**
 - Due to significantly decreased demand on our Placer Commuter Express service to Sacramento, we will be operating two commuter bus schedules each day instead of our regular four schedules beginning on Tuesday, March 24, 2020 until further notice.
- **Lincoln Circulator – Route #70**
 - Fixed route service will be suspended until further notice. Dial-A-Ride service is available upon request by calling (530) 745-7560
- **Lincoln School Tripper**
 - The Lincoln School Tripper will be discontinued as long as the schools in Lincoln are closed.
