**ACTION REQUESTED**

Approve appropriation of \$1000 in Revenue Sharing monies to Granite Wellness Centers as requested by Supervisor Weygandt (\$500) and Supervisor Holmes (\$500).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

Granite Wellness Centers provide an array of services to address substance use disorders and related behavioral health issues. The focus of the organization is on long term individual and family recovery, helping people become contributing members of their community and helping to build solid family foundations. Funding received will help the organization continue to connect remotely with clients by offsetting the costs of laptops, tablets, microphones, software, bandwidth services and other technology programs and equipment. Funding will also be used to alleviate the costs of cleaning products and other supplies that allow clinicians to safely provide direct services to those in residential treatment.
