SUBJECT: Revenue Sharing – Boys & Girls Club of North Lake Tahoe | Funding to help offset the cost of a virtual fundraiser

ACTION REQUESTED

Approve appropriation of \$1000 in Revenue Sharing monies to the Boys & Girls Club of North Lake Tahoe as requested by Supervisor Gustafson (\$1000).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Boys & Girls Club of North Lake Tahoe provides out-of-school programs for youth ages 3 to 18 who live in the North Tahoe and Truckee region. The organization's largest fundraising event of the year, Wine on the Water, has been cancelled due to the COVID-19 epidemic. The Boys & Girls Club will instead be hosting an online virtual auction and event in August. Funding will be used to implement changes necessary due to the cancellation of the Wine on the Water event and will to help offset the cost of administering the virtual event.
