SUBJECT: Revenue Sharing – William Jessup University, Jessup Gala | Funding for student scholarships and support services due to COVID-19

**ACTION REQUESTED**

Approve appropriation of \$1750 in Revenue Sharing monies to William Jessup University as requested by Supervisor Weygandt (\$500), Supervisor Uhler (\$1000) and Supervisor Gustafson (\$250).

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

William Jessup University is the only four-year private university in Placer County. The university has directly impacted the community by providing higher education since its arrival in 2004. The upcoming Jessup Gala benefits the students who attend the university by contributing proceeds to the Jessup Fund, which provides student scholarships that help to reduce or eliminate student debt. Revenue Share contributions will be used to offset the cost of the event. If the event is cancelled, contributions will be designated for student scholarships or as alternatives to student support services on campus and related expenses from COVID-19.
