The PCTPA is composed of nine (9) members, terms as appointed by City Councils and Board of Supervisors. Two members (2) from the Board of Supervisors, one (1) member at-large, appointed by the Board of Supervisors and one member (1) from each incorporated city. Meetings are held the fourth Wednesday of the month at 9:00 a.m. in the Board of Supervisors' Chambers, 175 Fulweiler Avenue, Auburn, CA 95603. Members receive \$100.00 per meeting plus mileage compensation for their services.
