SUBJECT: Revenue Sharing – Roseville Police Activities League | Funding used to help offset the cost of fundraising events

ACTION REQUESTED

Approve appropriation of \$1000 in Revenue Sharing monies to the Roseville Police Activities League as requested by Supervisor Gore (\$1000).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Roseville Police Activities League (PAL) provides a variety of year-round programs and services for Roseville youth ages 8 to 17. PAL also helps to build meaningful relationships between Roseville youth, police officers and the community through various events and activities. The goal of the organization is to keep costs for youth-oriented programs and activities low in order to avoid the exclusion of any child from these opportunities due to family income levels. Revenue Sharing funds will be used to help offset the cost of the organization's fundraising event, Bacon and Brew Bash and Crab Feed, or to offset the cost of outreach materials for other fundraising efforts should the event be postponed or cancelled due to COVID-19.
