ACTION REQUESTED

Approve appropriation of \$1750 in Revenue Sharing monies to Placer Food Bank as requested by Supervisor Gore (\$1000), Supervisor Weygandt (\$250) and Supervisor Uhler (\$500).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

Placer Food Bank serves as the foremost hunger-relief charity for Placer, El Dorado, and Nevada Counties and is the region's only Feeding America-certified food bank. The organization distributes fresh and non-perishable food to the hungry through its network of local charitable agency partners, serving people of all ages throughout local communities. The Placer Food Bank is requesting funds for its Kid’s Backpack Program, which is part of the organization’s Feed Our Future Program's. The Kid’s Backpack Program provides kid-friendly and nutritious snacks every Friday during the school year to students who qualify for the Federal Free and Reduced Lunch Program in Roseville City, Western Placer, and Auburn school districts. Funds will be used to offset the cost of supplies for this program.
