**ACTION REQUESTED**

Approve the reappointment of Shalon Warner to Seat #4, representing County Child Care Providers, and Teresa Dawson-Roberts to Seat #5, representing Public Agencies, on the Placer County Child Care Advisory Council

**BACKGROUND**

The Placer County Child Care Advisory Council was established by the Board of Supervisors in 1990 in order to implement recommendations contained in the Child Care Master Plan for Placer County. The basic premise of the Child Care Master Plan, and the goal of the Placer County Child Care Advisory Council, is to further efforts that provide opportunities for citizens of Placer County to obtain and maintain employment, including ensuring the availability of affordable quality child care services. Coordinated childcare services help working parents to remain employed, which creates a more stable and productive workforce.

The Child Care Advisory Council is comprised of 20 members representing the following groups: Consumers, Child Care Providers, Public Agencies, Community Representatives and Discretionary Members. The Board of Supervisors and the Placer County Superintendent of Schools each appoint ten members to represent the five membership groups, each of which may have up to four members.

Terms of each member shall be three years, with all terms ending on the 30th day of June of the corresponding year of their term. The Board of Supervisors shall appoint members from solicited applications by the County. The meetings are held the third Thursday of January, March, May, September and November. The presiding officer, as needed, may schedule additional meetings, including public meetings.

**COMPOSITION:** Res. 98-126 approving restructure of Committee. Representation: Board of Supervisors shall appoint ½ of the members in each category and the County Superintendent of Schools shall appoint the other ½ of the members. Up to 4 members shall be consumers of child care, up to 4 members shall be child care providers, up to 4 members shall be community representatives, up to 4 members shall be public agency representatives and up to 4 members shall be public members, at the discretion of the appointing agencies. Terms of each member shall be three (3) years and will end on the 30<sup>th</sup> day of June of the corresponding year of their term. The Board of Supervisors shall appoint members from solicited applications by the County.

**MEETINGS:** The third Thursday of the following months - January, March, May, September and November. The presiding officer, as needed, may schedule additional meetings, including public meetings.

**COMPENSATION:** Members shall receive no compensation for their services; however, any member traveling on official business for the Council shall be reimbursed for his actual and necessary traveling expenses.
