

DOES MY TENT REQUIRE A PERMIT?



TEMPORARY TENT AND MEMBRANE
STRUCTURE REQUIREMENTS IN
PLACER COUNTY California Fire Code Ch. 31



Permit Required If:

- 400 SQ FT OR MORE WITH SIDES
- 700 SQ FT OR MORE WITH OR WITHOUT SIDES
- IF ATTACHED TO A STRUCTURE
- IF ERECTED FOR LONGER THAN 180 DAYS
- IF ELECTRICAL IS USED BEYOND 120 AC VOLTAGE

On May 26, 2020, the Placer County Board of Supervisors approved an urgency ordinance (Ordinance No. 6020-B) to temporarily reduce regulations pertaining to implementation of outdoor dining areas located within unincorporated Placer County to assist with economic recovery from the COVID-19 crisis. The urgency ordinance was recently extended and will remain in effect through October 8, 2021 unless rescinded.

During the period of this urgency ordinance, established restaurants and mobile food vendors may be permitted to temporarily establish outdoor dining areas through approval of an Administrative Approval permit. Please note: The Administrative Approval permit is separate from any permit review or inspections from the serving fire agency or the Placer County Building Services Division for any temporary structures that require a permit as detailed on page 1 of this flyer. The Building Services Division is processing permits for these structures free of charge. Fire agency permit fees or waivers depend upon the serving fire agency.
