**ACTION REQUESTED**

Approve appropriation of \$500 in Revenue Sharing monies to the Loomis Basin Christmas Basket as requested by Supervisor Holmes.

**BACKGROUND**

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to the Loomis Basin Christmas Basket (LBCB), which provides more than 300 families, seniors and children with food, toys and books for the holidays each year. LBCB also provides volunteer opportunities for groups and individuals to engage with their community in order to improve the holiday season for those in need. This year, due to COVID-19, the LBCB will be providing gift cards to help meet the needs of the Loomis Basin Community. Revenue Share funds will be used to help offset the costs of gift cards for families in need.
