**ACTION REQUESTED**

Approve the reappointment of Ed Marquez to Seat #1 representing District 1 on the Library Advisory Board.

**BACKGROUND**

The purpose of the Library Advisory Board is to advise and make recommendations to the Board of Supervisors and the Placer County Director of Library Services concerning policies and procedures for the operation of the County Free Library System. The Advisory Board also advises the members of the Mountain Valley Library System Council about the needs and wants of the library patrons served by system libraries.

The Library Advisory Board is comprised of eight members each serving four-year terms. The appointments are made in accordance with Ordinance 4271-B to include six members appointed by the Board of Supervisors (one in each Supervisorial area, one in the North Tahoe area), and those terms coincide with the District Supervisor's term of office. Additionally, two members are appointed by the Auburn City Council. The Library Advisory Board meets the third Wednesday of alternative months at 10:00 a.m. at various Placer County Library branches.
