ACTION REQUESTED

BACKGROUND

The purpose of the Tahoe Basin Design Review Committee is to review a Design Review project ensuring that County ordinance regulations and adopted design standards and policies are met. Actions are taken by the Design Review Committee and a recommendation made to the Planning Services Division. The committee is composed of seven members appointed by the Board of Supervisors, with each member serving a two-year term. All members shall, at the time of appointment and at all times during term of office, be residents or property owners within the boundaries of the Tahoe Basin Design Review Committee. Meetings are called as needed by the Chair, however, not to exceed one meeting per calendar month. Meeting location varies and shall be noticed in compliance with the Brown Act.
