



Placer County Multi-Team Sport Approval Request Form

Per [guidance from the California Department of Public Health](#): "Any tournaments or events that involve more than two teams are not currently permitted in California. Exceptions may be made, with authorization from the local health department, for the following sports where individual competitors from multiple teams are routine: **track and field; cross-country; golf; skiing/snowboarding; tennis; and swimming/diving.**" The following form may be submitted to Placer County Public Health for approval of events in these categories. Please read instructions carefully before submitting. Events must adhere to [state guidance](#) around face coverings, observers, hygiene etc.

Instructions

1. Please fill out all the required boxes and sign and date the request for authorization. Do not fill out the grey shaded or (County Only) sections. Please include zip codes of all event locations and participating teams.
2. Please submit request for authorization **no less than 3 full business days** before the meet is to take place to allow time for processing, approval and communication.
3. Please complete in Adobe Reader and sign/send **electronically** rather than printing and scanning if possible. Please submit the request via email to COVIDreview@placer.ca.gov with the **subject line: SPORTS**. If you do not use the subject: **SPORTS**, your request may not be found or processed.
4. Placer County **can only** authorize events **taking place within Placer County or for schools/clubs who are located within Placer County**. If the meet/event takes place in a county that borders Placer County you will need to seek approval from the county the event takes place in. If it involves schools/clubs who reside in a county that borders Placer County they may need to get authorization from their county to participate in your event. (example: you may need authorizations from both Placer County and Nevada County for an event taking place at Boreal Ski Resort, involving Placer County and Nevada County schools.)
5. Placer County **cannot** approve **out of state multi-sport meets** at this time (meets/competitions between teams from states other than California).
6. All participating teams **must be located in** a California county that borders Placer County directly (Nevada County, Yuba County, Sutter County, El Dorado County, Sacramento County). CDPH is only allowing the following Purple Tier sports for events involving more than two teams at this time: track and field; cross-country; golf; skiing/snowboarding; tennis; and swimming/diving.
