SUBJECT: COMMITTEES AND COMMISSIONS – Placer County Older Adult Advisory Commission appointment

ACTION REQUESTED

Approve the appointment of Clayton Wyatt to Seat #22, representing A4A on Aging, on the Placer County Older Adult Advisory Commission.

BACKGROUND

The purpose of the Placer County Older Adult Advisory Commission is to provide a voice for older adults in county government. The commission also advises the Board of Supervisors and the Department of Health and Human Services on matters relating to the creation and delivery of services promoting the well-being and quality of life for older adults. All members shall reside or work within Placer County and have an interest in issues affecting older adults. The twenty-two board members shall be appointed by the Board of Supervisors and include the following representatives: One from each Supervisorial District (five members), three representing Public-at-Large, one representing Older Adult Collaborative, two representing Agency on Aging/Area 4 Governing Board/Advisory Committee, one representing CA Sr. Legislature, one representing Minority, six representing Senior Service Organizations for a total voting membership of nineteen. In addition, there are three non-voting members, one from Board of Supervisors or designee, one Health and Human Services Liaison, and one from the Agency on Aging/Area 4. The committee meets the third Tuesday of each month at 1:00 p.m. in the Auburn Library Beecher Room, 350 Nevada Street, and quarterly in Loomis when possible. COMPOSITION: All members shall reside or work within the County, have an interest in issues affecting older adults. Members shall be appointed by the Board of Supervisors. Each Commissioner shall be qualified, by experience, profession, and/or training, so as to be able to apply his or her knowledge, understanding and background with integrity and in keeping with the needs and resources of older adults in Placer County. To the best of our ability, Commissioners shall be representation of the population and geography of the County. Nineteen (19) total voting Commissioners shall be appointed to include a minimum of one representative from each Supervisorial District (5 members).

MEETINGS: 3rd Tuesday of every month at 1:00 to 3:00 p.m. alternating between the Ambassador Room, Auburn Animal Shelter, 11232 B Avenue and the Community Room, Granite Bay Library, 6475 Douglas Blvd

COMPENSATION: Commission members shall serve without compensation. However; appointed members shall be reimbursed for actual and necessary expenses incurred while performing official duties.
