

CONTRACT AMENDMENT

Begins: September 1, 2020

Description: First amendment to this contract between Advocates for Compassion Valley LLC, a limited liability company, hereinafter referred to as "CONTRACTOR" and the County of Placer, hereinafter referred to as "COUNTY," to increase compensation by \$450,000 for a revised total of \$670,000.

WHEREAS, COUNTY wishes to provide Adult Residential Treatment Services and medication support services, and

WHEREAS, CONTRACTOR is licensed by the Department of Social Services as a Social Rehabilitation Facility (SRF) and Certified by the State Department of Health Care Services for Adult Residential Treatment services, and

WHEREAS, it is necessary to modify the current agreement to increase compensation to commensurate with the demand for these services,

WHEREAS, it is understood and agreed by and between the parties of this Agreement that they wish to enter into this Agreement in order to provide a full and complete statement of their respective responsibilities in connection with this venture during the term of this Agreement, and

NOW, THEREFORE, IT IS AGREED BY BOTH PARTIES THAT, EFFECTIVE September 1, 2020, the following amendment is made to the original contract, additions are shown in bold italics, deletions are shown in strike-through:

3. **PAYMENT:** COUNTY will pay to CONTRACTOR as full payment for all services rendered pursuant to this Agreement in the amount set forth in Exhibit B, titled Payment Provisions. The payment specified in Exhibit B shall be the only payment made to CONTRACTOR for services rendered pursuant to this Agreement. The total amount of this contract and payments made under this Agreement shall not exceed ~~TWO HUNDRED TWENTY THOUSAND DOLLARS (\$220,000)~~ ***SIX HUNDRED SEVENTY THOUSAND DOLLARS (\$670,000)***. This rate shall be inclusive of all CONTRACTOR costs, including, but not limited to travel, transportation, lodging, meals, supplies, and incidental expenses except as otherwise might be specifically set forth in this Agreement. CONTRACTOR shall charge for travel according to the Federal General Services Administration (GSA) guidelines.
