ACTION REQUESTED

Approve appropriation of \$400 in Revenue Sharing monies to the Auburn Host Lions Club as requested by Supervisor Holmes (\$250) and Supervisor Gustafson (\$150).

BACKGROUND

In approving the following contributions, the Placer County Board of Supervisors finds that each and every approved contribution serves a public purpose by promoting the general welfare of the County and its inhabitants, therefore a benefit results to the County.

The Board of Supervisors is being asked to approve appropriations to the Auburn Host Lions Club to help fund their annual charity golf event.
